REMINDER ABOUT FEEA'S PANDEMIC PROGRAMS FOR FEDS

Since March, FEEA has launched a number of programs to assist federal civilian and postal employees during the coronavirus pandemic. Here's what we're doing now:

FINANCIAL ASSISTANCE

Have you had LWOP due to your own or a family member's COVID-19 illness or because you've had to quarantine? FEEA is offering up to \$1,500 no-fee, no-interest loans to help get you

back on your feet. For lower income feds, up to \$1,000 of the total assistance may be a grant instead of a loan.

We are also offering bridge grants to the families of feds who have passed away due to COVID-19, as well as to feds who have lost a spouse or child to COVID-19.
